CONCORDANCE RESOLUTION – LOAN BY MEANS OF NOTES IN THE AMOUNT OF \$1,527,000

WHEREAS the Town of Hampstead, by virtue of By-law N° 749, intends to borrow, by means of notes, an amount of \$1,527,000;

WHEREAS these purposes, it becomes necessary to modify the loan By-law under which the notes are issued;

On motion of Councillor Jack Edery, seconded by Councillor Harvey Shaffer, it was UNANIMOUSLY RESOLVED:

- THAT the preamble becomes an integral part of the entire resolution;
- THAT a loan by notes in the amount of \$ 1,527,000 under By-law number 749 is achieved;
- THAT the notes will be signed by the Mayor and the Treasurer;
- THAT the notes will be dated November 29, 2011;
- THAT the interest on the notes will be payable semi-annually; and
- THAT the capital of the notes will be reimbursed as follows:

2012	\$ 74,000
2013	\$ 77,000
2014	\$ 80,000
2015	\$ 84,000
2016	\$ 88,000 (to be paid in 2016)
2016	\$ 1,124,000 (to be renewed)

- THAT in order to realize this loan, the municipality must issue notes for a term shorter than the term provided for in the loan by-law, that is for a term of:

five years (beginning November 29, 2011); instead of the term prescribed for the annual capital amortizations for the year 2017 and subsequent years for By-law number 749, each subsequent loan must be for the balance or part of the balance of the loan.
