ADOPTION OF DRAFT BY-LAW NO.791 AMENDING ZONING BY-LAW NO.727 OF THE TOWN OF HAMPSTEAD, SUBDIVISION BY-LAW NO.728 REGULATING CADASTRAL OPERATIONS IN THE TOWN OF HAMPSTEAD, BY-LAW NO.730 CONCERNING PERMITS AND CERTIFICATES AND BY-LAW NO.759 CONCERNING THE DEMOLITION OF BUILDINGS
